MAGGIE'S PLACE OPERATES FOUR MATERNITY HOMES IN MARICOPA COUNTY THAT PROVIDE A STABLE ENVIRONMENT, SUPPORT RESOURCES AND A POSITIVE, HEALTHY COMMUNITY FOR PREGNANT WOMEN EXPERIENCING HOMELESSNESS. MAGGIE'S PLACE ALSO OPERATES TWO TRANSITIONAL APARTMENT COMPLEXES (15 UNITS TOTAL) THAT PROVIDE HOUSING TO MOTHERS WHO HAVE TRANSITIONED FROM OUR MATERNITY HOMES AND ARE CONTINUING TO ESTABLISH STABILITY AND INDEPENDENCE.
